

Fish are not mentioned.

I attach a photograph of the Cuprinol label.

The phrase "... cover fish ponds before application" clearly indicates that, after application, Cuprinol is safe for fish.

The phrase "... and animals should be kept away from treated areas for 48 hours or until surfaces are dry" gives the clear indication that, when dry, Cuprinol is safe for animals.

The phrase "Harmful to aquatic organisms" does not include fish because I have purchased (but not yet used) a Tetra Pond product to use in my fish pond. Exactly like the Cuprinol tin, the label states "Harmful to aquatic organisms, may cause long-term adverse effects to the aquatic environment". But it also states "Pond Approved" and "Safe for fish and plants".

I attach photographs of the Tetra Pond labels.

On 15th June 2016, after several fish had died, the Cuprinol telephone helpdesk initially said it was safe to use their product with fish ponds, provided that the timber treatment had dried and, ideally, had been allowed to weather. However, the adviser checked with a colleague and said his advice related to their previous formulation of Exterior Wood Preserver and that the current formula was not recommended for our application.

We are very distressed by this experience and feel that Cuprinol have been negligent in labelling their current product. I believe they should compensate us. The financial cost alone is more than £2,500 so far.

Proposed new heritage centre receives over £0.5million grant

Suffolk County Council's Record Office has received support and a grant of over £0.5 million from the Heritage Lottery Fund (HLF) towards their proposals for a new heritage centre. The development funding of £538,100 has been awarded to help Suffolk County Council progress their plans to apply for a full grant of £10.3m at a later date. Located on the university's north campus, the new facility will house the bulk of Suffolk's nationally and internationally significant archives and a range of archaeological records. As well as providing teaching and research space fit for the 21st Century, it will also form a unique visitor attraction and an important cultural resource for the community. The project will drive a new way for the Record Office to extend and deliver its outreach work; a county-wide activity programme called "Mapping Suffolk's Stories" will see Record Office staff and UCS work alongside a wide range of community groups, volunteers and schools, engaging them with Suffolk's rich heritage in new and exciting ways, beginning with researching and digitising historic map collections. The Hold, which is one of the 21 key delivery projects of the 'Ipswich Vision', should open its doors in time for the 900th anniversary of the Record Office's oldest document, in 2019.

Extended weekend hours at Suffolk's Household Waste Recycling Centres

£10million of road surfacing work taking place during spring and summer 2016

Suffolk County Council is allocating £10million of additional investment from its reserves into 2016's programme of road surface dressing during the spring and summer months before September. This preventative maintenance work will help avoid potholes forming in future years on the roads that are treated by delivering approximately three million square metres of new surfacing; particularly focusing on rural roads across the county. This intensive programme of work equates to delivering three times the usual amount of new surface dressing, and is equivalent to dressing 500km of road surface. To put that in perspective, Suffolk has around 6500km of road network so this year's work will cover almost 10 per cent of the network. To carry out this work in the most effective manner, surface dressing will take place in the areas of the highest priority, based on the Council's recently adopted asset management approach to highway infrastructure. This surface dressing work can be affected by poor weather as the dressing materials need the right conditions to set correctly. Any programmed work that is unable to be completed during this summer will be carried over to next spring.

Consultation begins on three new River Orwell crossings

Suffolk County Council has launched a consultation with residents, businesses, community representatives and visitors to Ipswich about its proposal for three new River Orwell crossings close to Ipswich town centre – the Upper Orwell Crossings. The three crossings proposed are:

- A new road crossing to the south of the Wet Dock Island, which would connect the east and west banks. The crossing would be for all road users including cyclists and pedestrians
- A new road crossing of the New Cut, which would connect the west bank to the Wet Dock Island. This crossing would be for all road users including cyclists and pedestrians
- An improved crossing over the Prince Philip Lock, which would connect the east bank to the West Dock Island. This bridge would be for cyclists and pedestrians only.

In March 2016, Suffolk County Council received a provisional funding agreement of £77million from the Department for Transport for the Upper Orwell Crossings. This followed the approval of its Outline Business Case which demonstrated how the proposed crossings would support investment, enterprise and regeneration in Ipswich, and would relieve congestion and improve connectivity for all road users.

To summarise, the proposed devolution deal includes £750m from Government to invest in infrastructure, economic growth and jobs (£25m a year for 30 years, reviewed every five years) and a total of £130m to invest in housing. The Combined Authority would also receive a single budget for public transport guaranteed for four years, replacing the numerous annual budgets that Government currently provides.

Norfolk / Suffolk Devolution: Frequently Asked Questions

Q. What is the benefit of Devolution?

A. Devolution moves decisions currently made by central government in Westminster to a local level, offering greater local control over the decisions that impact on our lives. It gives us the chance to prioritise and accelerate improvement of our roads, railways and digital connectivity, as well as creating jobs and building homes where they are needed.

Q. What are the costs associated with a Combined Authority and a Mayor?

A. There will be costs but we will be looking to reallocate resources and expertise from within member authorities to deliver the work of the Combined Authority

Q. Isn't this just an additional tier of Government?

A. These are decisions that are currently being made by central government. Devolution is about taking powers from central government and making decisions locally on local issues.

Q. Won't it be impossible to get anything done as all leaders will only be after what benefits their area?

A. Not at all, the Governance Scheme requires the members of the Combined Authority to act in the best interests of the area as a whole and proposes the way in which decisions will be taken to ensure that devolution delivers for Norfolk and Suffolk

Q. What proposals are in future deals?

A. Whilst these are being developed our main focus is the proposed deal in front of us right now. However, if the Combined Authority goes ahead we are looking to negotiate our second deal this autumn.

Q. How do you know government will sign off on the proposed deal?

A. The proposed deal is based on the devolution deal for East Anglia announced by the Chancellor in the March Budget. Since then, we've been working closely with Government to develop the two sister deals now proposed for Norfolk and Suffolk and Cambridgeshire and Peterborough.

Q. What if Government changes your proposed deal?

A. As we've been working closely with Government over a number of months on developing the proposed we think this is unlikely. However, in the event of significant changes being made, councils would have to consider the deal again.

Q. Where would the Combined Authority and Mayor be based?

A. This is still to be decided but in the spirit of efficiency, we would expect to use our existing buildings

Q. Who can be Mayor?

A. Anyone. Elections are due to take place in May 2017

Q. When would the Combined Authority and Mayor come into being?

A. Mayoral elections are due to take place in May 2017. The creation of a Combined Authority requires parliamentary debate and approval. If the participating councils agree to the draft Order to create the Combined Authority in October it would probably be created by the end of the calendar year. In any event it would need to be created before the Mayoral elections in May 2017

Q. Would the Combined Authority take powers away from local areas?

A. No, devolution is about getting new powers and funding from central government. How these powers are delivered will be decided locally and could involve existing authorities taking on responsibilities for local delivery.

Q. Can any Government really give a commitment for 30 years?

A. If Government enters into an agreement with us on those terms we expect them to be honoured. However, we don't have the power to bind future administrations.

Q. How will the money be shared out across the areas?

A. The proposed deal document set out how much funding Norfolk and Suffolk would receive. It will be for the Combined Authority and Mayor to decide on spending priorities.

Q. My council didn't endorse the proposed devolution deal. What does that mean for me?

A. As a resident of the county you can still provide your views in the consultation. Your Council could join the Combined Authority, if created, at a later date.
