B/F: BPC/23/42 b)	 Brundish resident highlighted a recent road accident and asked what could be done to lower the village speed limits? Introducing a new limit requires a range of legal thresholds to be met, for example minimum housing density over a given distance. Rural roads with low density housing are unlikely to meet some or all of those thresholds. Can prove to be a lengthy and costly exercise Who bears the cost? - comes out of SCC Budget/local Council
	 Who bears the cost? - comes out of SCC Budget/local Council contribution. There may be other effective and more viable options available. Resident advised to e-mail Cllr Hicks and BPC if further action required. Reference was made to the '20's Plenty' reducing speed limits campaign – Cllr
	M Hicks advised this is an advisory limit only and is restricted to use in urban areas.
